* Reports from subcommittees

■ Library Link NJ (Sophie Brookover)

- The Future of LibraryLinkNJ• A brief snapshot of results from our Save LLNJ Survey, which closed on 9/20: Would you support the library community prioritizing its funding request to the legislature to identify stable, ongoing funding for LibraryLinkNJ as the top priority for library funding in FY2019 and FY2020?o Total responses: 6890 YES: 94% (645)o NO: 6% (44)Background information: LibraryLinkNJ has adopted a budget for July 2018 June 2019 that requires libraries participating in delivery services to contribute to its cost for the period January 1, June 30, 2019.
- The current budget even with library contributions for delivery is still \$370,000 short of full funding for LibraryLinkNJ. This deficit is the result of several unfortunate circumstances, including an increase in the cost of services and continued flat funding from the state. In years past, we have made up for any deficits through reserve funding.

That funding, however, has now run out. If additional funding is not secured and secured soon, LibraryLinkNJ will close for good. LibraryLinkNJ has already had to put a contingency plan in place, with staff layoffs starting in January 2019 and with LibraryLinkNJ dissolving entirely in June 2019. There is great uncertainty regarding the future of all of the services LibraryLinkNJ provides: delivery, continuing education, innovation projects, and a voice for advocacy for the entire library community as a whole.

- LibraryLinkNJ is funded through the Network Aid line in the State Library's budget. That budget line funds a number of other services in addition to LibraryLinkNJ. We are doing this survey in hopes of demonstrating that there is a high level of consensus among the library community to sustain funding for LibraryLinkNJ and its services into the future. We appreciate your time and hope you will join our efforts to save LibraryLinkNJ!• Advocacy Form: Action Item open until further notice. We're gathering stories from staff at member libraries about the difference LibraryLinkNJ has made in your careers and in your libraries' abilities to serve your communities. If you have a specific story to share about LibraryLinkNJ services -- continuing education, innovation project funding, and delivery -- we'd love to hear from you!

■ Garden State Book Awards (Robin Rockman)

- We met on September 28th, 2018 for our first meeting of the new year.
- We have a full committee, reaching our cap of 20 members. We are requesting approval from the CSS Executive Board to allow us to increase or remove the limit so that we

can bring on more readers and keep on school media specialists as readers, even though they are having an increasingly difficult time making the meetings

- The current ballot is out now! Please encourage your readers to vote. We have a brand new category of Graphic Novels (replacing our Series category). The deadline for libraries to submit their tallies is January 11, 2019.
- We will have a table at the Youth Services Forum on October 29th at Monmouth County to promote the award
 - We would like to update our logo.
- We would also like to update our voting guidelines. In the past, all votes were submitted on behalf of the libraries. I have attached our voting guidelines so you can see the formula for determining the winner. However, as we have started to shift towards individual online voting, and feel that this is where all voting will be heading, our formula does not really account for these votes. We would like to revise our guidelines to account for this shift. We don't see this change happening with the current ballot, but for the 2019-2020 ballot. Basically, it would free up librarians to direct voters to online voting, which we think would be easier for libraries to engage their readers. All votes would be counted individually. The Young Adult Section has made this transition already, but our formula for determining winners has held us back.

***CSS members agreed to changing the voting guidelines and tentatively agreed to changing membership cap, tabling it for the November meeting for formal approval.

■ Public Policy (Jen Fitzgerald)
