2. NJLA Conference 2015 : finalizing proposals

April 20-22 at Ocean Place, Long Branch.

Deadline for session proposals: November 21.

a. Collection development and maintenance of eResources: What You Should Know.

Confirmed speakers: Tina Marie Doody (eLibraryNJ), Ruth Bogan (DigitalLibraryNJ) and Chuck Dolan (Middlesex County College). The following topics have been suggested by the participants:

Tina Marie Doody—collection development practices of eLibraryNJ; collection development as a consortia; maintenance in terms of dealing with the multiple licensing criteria we are faced with thanks to publisher restrictions.

Ruth Bogan (DigitalLibraryNJ)—to be determined.

Chuck Dolan (Middlesex County Library)—a patron-driven acquisition model; how the PDA profiles are set up in ebrary and the challenges of maintaining them, as well as what's involved in managing a PDA collection of ebooks in the library's ILS.

Managing a PDA collection in the ILS is different than a standard subscription ebook collection, because there are 2 classes of records that must be managed—one for items that are accessible to users but not owned, and another for those that have already been purchased. As purchases are triggered by patron use, items must be changed from one category to the other.

b. RDA authorities program

Cathy Weng (TCNJ) will present an overview of authority control, why it is important for public libraries and how to perform authority control locally. She will also provide sample RDA authority records and explain how data elements in an authority record can help cataloger.

c. Audiobooks in RDA

Mark Sandford (William Patterson University) will present a program with a field-by-field review of changes.

d. Seamless Integration: eBooks, OPACs and the Changing Face of Libraries

Heidi Schwab (Morristown Public Library) and Anastasia Vito (South Jersey OverDrive consortium)—a roundtable discussion.

As ebooks become easier to borrow from libraries, it will change the way libraries look and operate in the future. Ebook vendors like 3M and OverDrive allow simple, instant downloads right from library OPACs. What does this mean for the future of print books, library physical spaces and walk-in patrons? Ashley will contact Anastasia. There will be ample time for questions.
