      - Perhaps a skill sharing session within the section.

  discussion of Critical Cataloging, in addition to resources where we can find

  - Using alternative Dewey assignments for the 220s (example project undertaken by Lawrence PL, KS from the Dewey blog) or ditching Dewey in favor of BISAC or other classification system for non-fiction.

  - This was a topic of interest on our TS CD survey
    - Bernards Township presented on knowing your community.
    - May have had more to do with weeding
